At the same time, it provides people with more opportunities for outdoor activities and encourages them to get close to nature and enjoy a healthy lifestyle, such as organizing forest hiking, cycling, camping and other activities [6].

3. The Realistic Dilemma of Forest Recreation Industry in Boosting the Development of Rural Revitalization

3.6. Lack of Industry Standards

As an emerging industry, the forest recreation industry still lacks unified industry standards. At the same time, the lack of industry standards also makes consumers in the choice of forest recreation products and services

lack of basis, affecting consumer confidence and satisfaction.

The deep integration of the two should be vigorously promoted to inject new vitality into rural revitalization. First, continue to increase investment in the construction of forest recreation bases. Not only should the level of infrastructure be upgraded, but a comprehensive recreation site integrating various functions such as leisure, health maintenance, rehabilitation and holiday should also be carefully built. From comfortable accommodation facilities to convenient traffic conditions, from perfect medical support to delicious health catering, every detail should be carefully carved. Secondly, we will actively develop diversified forest recreation products and services. Forest bathing, which allows people to feel the embrace of nature in the fresh air and relax their bodies and minds; forest yoga, which allows people to stretch their bodies in the tranquil forest environment and achieve physical and mental harmony; and forest food therapy, which makes use of natural ingredients in the forest to provide people with healthy and delicious dietary experiences. Thirdly, we will strengthen close co-operation with tourism enterprises to fully expand market channels. Through joint promotion and resource sharing, the visibility and influence of the forest recreation industry can be improved to attract more tourists to come and experience it, thus driving the development of the rural economy.

4.2. Ecological Livability: Adhere to the Green Leadership, Protect the Forest Recreation Resources and Rural Ecology

Establish a sound quality supervision system, conduct strict quality testing of forest recreation products and services, and protect the legitimate rights and interests of consumers. Secondly, training and guidance for rural migrant workers will be strengthened. Activities such as forest recreation skills training and entrepreneurship training have been carried out to improve their entrepreneurial and employment abilities. Third, provide strong talent support for the development of the forest recreation industry through the introduction of professional talents and the cultivation of local talents. [16] Introduce professional forest re-creationists, nutritionists, tourism management personnel, etc. to improve the service level of the forest recreation industry. Cultivate local talents and encourage rural youth to enroll in relevant professions, so as to reserve talent power for rural revitalization. Promote rural revitalization with talents, achieve the prosperity of rural people, and give the countryside a new vitality and vigour.

5. Conclusion

The forest recreation industry has significant value implications in promoting rural revitalization, covering ecological, economic, social and health values. However, the forest recreation industry in rural development is currently faced with the constraints of traditional concepts, lack of human resources, insufficient knowledge of recreation, defective project design, lagging industrial planning and lack of industry standards.
